DECISION

Amending and supplementing the Plan to restructure crop production replacing rice cultivation land in the 2019-2020 period (2nd time)

MINISTER OF AGRICULTURE AND RURAL DEVELOPMENT

Pursuant to the Government's Decree No. 15/2017/ND-CP dated February 7, 2017 defining the functions, tasks, powers and organizational structure of the Ministry of Agriculture and Rural Development;

Pursuant to the National Assembly's Resolution No. 134/2016/QH13 dated April 9, 2016 adjusting the land use planning to 2020 and the national land use plan for the last period (2016-2020);

Pursuant to the Government's Decree No. 01/2017/ND-CP dated January 6, 2017 amending and supplementing a number of Decrees detailing the implementation of the Law on Land;

Pursuant to the Government's Decree No. 35/2015/ND-CP dated April 13, 2015 on management and use of rice cultivation land;

Pursuant to the Government's Decree No. 62/ND-CP dated July 11, 2019 amending and supplementing a number of articles of the Government's Decree No. 35/2015/ND-CP dated April 13, 2015 on management and use of rice cultivation land;

Pursuant to the Prime Minister's Document No. 1927/TTg-KTN dated November 2, 2016 on allocation of national land use norms;

At the proposal of the Director General of the Department of Crop Production,

DECIDES

- **Article 1.** To promulgate together with this Decision "Amendment and supplement to the Plan to restructure crop production replacing rice cultivation land in the 2019-2020 period (2nd time)".
- **Article 2.** Departments of Agriculture and Rural Development of provinces and cities under central authority are responsible for:
- 1. Preparing and submitting to the People's Committees of provinces and cities directly under the Central Government for promulgation a plan to restructure crop production on the province's rice cultivation land based on the Plan to restructure crop production of the Ministry of Agriculture and Rural Development;
- 2. Guide and inspect the implementation of crop restructuring on rice cultivation land in the province;
- 3. Periodically before December 31 every year, summarize the results of crop restructuring on rice cultivation land according to the form in Appendix VII attached to the Government's Decree No. 62/ND-CP dated July 11, 2019 amending and supplementing a number of articles of the Government's Decree No. 35/2015/ND-CP dated April 13, 2015 on management and use of land for rice production;

report to the People's Committees of the provinces and cities directly under the Central Government, the Ministry of Agriculture and Rural Development (via the Department of Crop Production).

Article 3. Provinces that do not need to amend and supplement the Plan to restructure crop production replacing rice cultivation land in the 2019-2020 period will continue to comply with the Decision No. 586/QD-BNN-TT dated 12 February 2, 2018 by Ministry of Agriculture and Rural Development.

This Decision takes effect from the date of signing.

Article 4. Chief of the Ministry Office, Director General of the Department of Crop Production, Heads of units under the Ministry and Departments of Agriculture and Rural Development of provinces and cities directly under the Central Government are responsible for implementing this Decision.

In the course of implementing the Plan, if any problem arises, the People's Committees of provinces or cities directly under the Central Government shall report to the Ministry of Agriculture and Rural Development for review, adjustment and supplement./.
