Viet Nam Coffee Cordination Board implements tasks for 2022

On the morning of October 26th, 2022 in Buon Ma Thuot city, the Institute of Policy and Strategy for Agriculture and Rural Development (IPSARD) in collaboration with the Department of Crop Production held the 2022 annual Viet Nam Coffee Coordination Board (VCCB) Meeting with the participation of Co-chairs of the PPP Task Force on Coffee, research institutes, companies and organizations involved in the field of coffee production and trade. The Meeting focused on evaluating results of the public sector's work in developing and implementing policies, proposals for coffee replantation, developing specialty coffee, orienting the development of the coffee industry and providing an operational plan for 2023.

Sustainable development of Viet Nam coffee industry

On December 11th, 2022, Viet Nam Coffee Cocoa Association held the International Conference in Viet Nam Coffee Industry 2022. Attending the Conference were representatives of Ministry of Agriculture and Rural Development. Ministry of Industry and Trade, ICO's CEO, President of the Colombian Coffee Federation, Vice President of the International Coffee Council, etc, and coffee trading and exporting enterprises in Viet Nam. At the Conference, delegates heard many presentations on the export prospect of Viet Nam's coffee industry and the role of publicprivate cooperation in sustainable coffee production.

2 PPP Task Force (TF) on Fruits and Vegetables:

Public Private Cooperation on potato development


On the morning of October 24th, 2022, Deputy Minister of Agriculture and Rural Development Le Quoc Doanh had a Meeting with Ms. Monica Bauer, Vice President of External Relations of Pepsico. Deputy Minister Le Quoc Doanh said that there are currently many reasons affecting potato production in Viet Nam, therefore leading to low output, about 20,000 - 25,000 ha/year and not meeting the needs of the market:

+ Strict standards to ensure standards of plant protection;

+ The economic efficiency is not high, so farmers have many other options instead of growing potatoes;

+ Potato seeds are difficult to store, plus the price is still high, so the area is shrinking.

Therefore, Deputy Minister Le Quoc Doanh recommended that there should be an overall assessment for potato in order to remove bottlenecks step by step towards the goal of meeting 100% of raw material demand of the market as well as Pepsico in Viet Nam. More specifically, the Deputy Minister suggested Pepsico could grow potatoes in the spring crop in the northern mountainous areas and the

winter crop in the Red Delta provinces. However, Deputy Minister Le Quoc Doanh noted that each region needs to evaluate and offer its own solutions to current problems such as varieties, competitiveness, economic efficiency or linkage model.



Prospects for the public private cooperation in the sustainable development of Viet Nam's vegetable industry

On the afternoon of December 7th, 2022, the Secretariat of the Parnership for Sustainable Agriculture in Viet Nam (PSAV) in collaboration with Syngeta Viet Nam and Pepsico Viet Nam organized the Workshop on Fruit and Vegetable Outlook in Viet Nam in Lam Dong to summarize the Task Force's activities in 2022, share prospects for cooperation, promote trade and investment in the form of public private partnership (PPP) in the vegetable industry in Viet Nam.

At the Workshop, Syngenta Viet Nam and Pepsico Viet Nam signed the Memoradum of Understanding for the period of 2022-2025, continuing to accompany towards the target of reaching 2,000 ha of potato cultivation in Lam Dong, Dak Lak and Gia Lai with participation of more than 1,000 farmers.

3 PPP Task Force (TF) on Fisheries:

Seafood exports exceeded \$10 billion fo the first time

Despite the difficulties, the fisheries industry is still expected to end 2022 with the \$11 billion mark, a record number of the industry for over 20 years. To commemorate this event, on the Evening of December, 10th, 2022, the Viet Nam Association of Seafood Exporters and Processors (VASEP) held a celebration upon seafood exports reaching \$10 billion at Sheraton Hotel, Ho Chi Minh City. As of November, 2022, seafood exports have reach a value of nearly \$10.2 billion, a raise of nearly 28% over the same period in 2021. The fisheries industry aims to export \$14 billion by the year 2030.

4 PPP Task Force (TF) on Pepper and Spices:

Viet Nam International Pepper Outlook 2022

The Outlook held on November 9th, 2022, which is within the framework of the National Trade Promotion Program 2022 hosted by the Viet Nam Pepper Association with the aim of:

- Promote Vietnamese pepper, the Outlook is a chance for Vietnamese pepper producers, processors and exporters to meet and exchange with world pepper traders. This is also an opportunity for customers to better understand the production and market of Vietnamese pepper, contributing to increasing exports for Vietnamese pepper;

- Identify the opportunities and challenges that are posed to the pepper industry, better understanding of the production and quality of Vietnamese pepper;

- Update the requirements and consumer tastes of the import markets through the perspective of experts from the globally renowed pepper and spice industry;

During the Outlook, the Viet Nam Pepper Association signed a Memorandum of Understanding with the People's Committee of Dak Lak province on: "Developing a supply chain of pepper and spices including production, deep processing and consumption".

Support training on sustainable pepper farming

On the morning of November 9th, 2022, the Viet Nam Pepper Association (Co-chair of the PPP Task Force on Pepper and Spices) organized a training session for more than 100 pepper farmers in Dak Lak, Dak Nong and Gia Lai provinces on sustainable pepper farming techniques.

5 PPP Task Force (TF) on Agro-Chemicals

Initiating the "Clean Enviroment - Green Life" Campaign



The campaign "Clean Environment - Green Life" has been held for 8 years in many localities across the country.

On December 7th, 2022, in Tu Tra commune, Don Duong district, Lam Dong province, Syngenta Viet Nam - a member of the PPP Task Force on Agro-Chemicals in collaboration with the Sub-Department of Crop Production and Sub-Department of Plant Protection of provinces and cities: Lam Dong, An Giang, Dong Thap and Can Tho launched the 8th series of "Clean Environment -Green Life" campaign in 2022. Up to now, Syngenta Viet Nam has organized training on the safe and effective use of pesticides for more than 15,000 farmers, more than 80 tons of packaging have been collected and destroyed; the Campaign has been launched in 15 districts/provinces and cities across the country; thereby helping farmers use pesticides in compliance with the principle of "4 right" to effectively manage pests and diseases but still ensure health and environmental safety, products that meet food safety and hygiene standards for export.

ASEAN Food and Agriculture Roadmap Towards the 2022 United Nations Climate Change Conference (COP27)

On the morning of September 30th, 2022, the Workshop on the ASEAN Food and Agriculture Roadmap - Towards

COP27 was held in Ha Noi co-chaired by the US-ASEAN Business Council, Canada-ASEAN Business Council, Partnership for Sustainable Agriculture in Vietnam (PSAV) and CropLife Asia. The Workshop was organized with the objectives of sharing the results of the survey for policies makers on the impact of climate change on ASEAN agriculture conducted in 2022; sharing perspective and solutions to respond to climate change and ensure a sustainable food production system for the region from the delegates attended. The Workshop received a lot of comments and recommendations from the participants.

On November 14th, 2022 in Hung Yen, the Department of Plant Protection - Co-chair of the PPP Task Force on Agro-Chemicals opened a training course on testing pesticides in the North for 80 trainees working at the Sub-Departments of Crop Production and Sub-Departments of Plant Protection of the Northern provinces, institutes, universities and centers and units under the Ministry of Agriculture and Rural Development. The contents of the training on testing pesticides include: updating current legal documents on pesticide management; safety in the use and storage of pesticides; methods of arranging, designing, collecting data, processing and synthesis of report on a testing of pesticides in accordance with regulations. In addition, the training course also improved the trainees' ability to indentify newly emerged harmful organisms and new active ingredients. Especially, the training course also introduced participants to a new testing method: testing pesticides with UAV/Drone. This is one of the new methods, especially in the 4.0 era. Applying the outsanding advantages of technology in terms of efficiency, accuracy and ability to save labor; reduce labor costs; improve productivity and quality of agricultural products; higher capacity; protect the health of farmers by not having to directly contact with pesticides.



On December 5th, 2022, Ministry of Agricultue and Rural Development held the PPP Task Force Plenary Meeting within the framework of PSAV 2022 with the theme "Adding Green and Value to Agriculture".

The agricultural sector is currently facing global challenges to provide enough food and fuel, meeting ever-changing and growing needs amind ongoing conflicts, climate change and epidemics worldwide, food supply chains disrupted by the Covid-19 pandemic. Therefore, innovation system in agriculture need to develop and disseminate innovatice initiatives that can improve productivity and sustainability in the food supply chain and help to cope with challanges.

Promoting public-private cooperation to develop a green agriculture, innovation and value addition is essential, thereby attracting investment capital from the private sector, domestic and foreign enterprise, to restructure the sector, transform the agricultural sector towards ecological agriculture, sustainability, biodiversity, emission reduction, adaptation to climate change" Minister Le Minh Hoan emphasized.

Within the framework of the Plenary Meeting, as Co-leader of the PPP Task Force on Fruits and Vegetables, Syngenta Viet Nam and PSAV signed a Memorandum of Understanding on Public-Private Cooperation to Promote Sustainable Agricultural Development. The objectives of the Memorandum of Understanding are to develop value chain linkage models between farmers and markets to improve production processes in order to reduce costs, improve quality, ensure pesticide residues, and meet the requirements of exporting to major international markets.

At the event, PSAV signed a Memorandum of Understanding with Grow Asia. The signing of the Memorandum of Understanding formalizes and strengthens the ongoing relationship between the two Organizations, built on seven



years of cooperation and partnership. The Memorandum of Understanding paves the way for the establishment of the region's first Food Innovation Hub. The Memorandum of Understanding will allow Grow Asia and PSAV to mobilize additional resources from the public and private sectors to jointly develop multi-stakeholder case studies, research projects and value chains to enhance the economic value of Vietnam's key agricultural sector while supporting the development of sustainable and climate smart food systems.



MOBILIZING RESOURCES TO DEVELOP GREEN, LOW EMISSION AGRICULTURE

The 27th Conference of the Parties to the United Nations Framework Convention on Climate Change (COP27) opened on November 6th, 2022 in Sharm El-Sheikh, Arab Republic of Egypt, with the participation of more than 120 heads of state and nearly 40,000 delegates.

SUGGESTING SOME SOLUTIONS, ORIENTATION ON VIETNAM'S AGRICULTURAL MARKET

On November 4th, 2022, the Institute of Policy and Strategy for Agriculture and Rural Development (IPSARD), Ministry of Agriculture and Rural Development in collaboration with the Agro Processing and Market Development Authority and the support of the Australian Program to Support Vietnam's Economic Reform (Aus4Reform) organized a Workshop to assess the prospect of Viet Nam's agricultural market.

Through discussion focusing on key issues related to forcasting the world agricultural production, consumption and trade, focusing on 3 key commodities: rice, fisheries and coffee. The workshop suggested a number of solutions to promote Viet Nam's agro-forestry and fisheries exports. Accordingly, in the context that world energy prices are expected to remain high, which may increase the price of commodities, especially food, leading to challenges for ensuring food security and reducing the value of agricultural product surpluses. Viet Nam needs to focus on solutions to ensure food security, while increasing agricultural product exports.

Besides producing sustainable products, reducing

emissions, better meeting international demands; comply with the conditions for the early removal of the European IUU "yellow card", Viet Nam also needs to complete its production process to meet the standards of importing countries. In particular, in addition to focusing on strengthening connections with markets to better exploit rooms and take advantage of strengths, in the coming time, Viet Nam also needs to develop stronger warehousing infrastructure and logistics systems, transport by railway, by seaway etc, Thereby, increasing opportunities to export official agricultural products to the main market of China, as well as connecting more closely with the border trade system with countries in the region.
